Polling was conducted online from December 1-5, 2025 Using Dynamic Online Sampling to attain a representative sample, Change Research polled 2,079 registered voters in Kentucky. Post-stratification was performed on age, gender, race/ethnicity, education, region, and 2024 presidential vote.
